PRELIMINARY NOTES

1. Subject

The above-mentioned contracting parties hereby agree to cooperate for an indefinite period of time, but at least 12 months, in the field of international certifications in accordance with ISO standards. This applies primarily, but not exclusively, to the certification of persons in accordance with the international standard ISO 17024 and the certification of service processes in accordance with the international standard ISO 9001.

Furthermore, InterCertConsult, as an ISO-certified Internet and web service provider, provides online support for the use of administrative programmes for company management.

This agreement and the agreed services shall commence on August, 1st 2025; invoicing shall take place immediately after the final licensing of the company by RAKEZ/Ras al Khaimah, retroactively. Further services may be agreed between the partners at any time.

2. InterCertConsult

InterCertConsult FZ-LLC has been buildt for consult insripted partners

- in all questions of job education and necessary certifications in order to the global rules of ISO-certifications, specially the ISO 17024, but also ISO 9001 in it's actual forms.
- Also InterCertConsult will manage online the web administration and the internet programmes for processing internal company tasks such as accounting and human resources management, as well as external tasks such as customer management, distribution, consulting and sales.
- For these services, InterCertConsult will conclude service agreements with partners for fixed terms, in which the services are defined and described and which commit to monthly basic payments for the term of the agreements.

AGREEMENT & CONTRACT

1. InterCertReport

The InterCertReport is usually published monthly* and contains valuable information on the following topics

- Dissemination of international standards worldwide
 - Special information on working methods and procedures in the respective partner country
 - Administrative bodies in the partner countries that are entrusted with ISO certifications, including accreditation bodies where applicable
 - References to further sources of information
 - Harmonization issues on the basis of the International Standardization Organization (ISO).
- *) InterCertConsult endeavors to produce monthly reports, but delays are often unavoidable due to the time-consuming research involved.*

2. InterCertWebservices

InterCertConsult gives support in all web administration and the internet programmes for processing internal company tasks such as accounting and human resources management, as well as external tasks such as customer management, distribution, consulting and sales.

3. InterCertPartners – Members

InterCertConsult works solely and exclusively with and for registered partners who have signed this agreement.

4. InterCert fee rates (as of August 2025)

InterCertConsult continuously charges its partners, the so-called members, for its services on a monthly basis.

The fees are staggered and depend on the turnover of the affiliated members.

InterCertConsult distinguishes between small companies with a turnover of up to AED 500,000.00 and large companies with a turnover of more than AED 500,000.00.

The members make a declaration to this effect; the principle of trust applies.

This agreement starts in _____ 2025 and is not limited in time. The minimum term is 12 months. After this period, the agreement can be terminated by either party at any time with a notice period of 3 month and without giving reasons.

Any modification of this Agreement shall be effective only if both parties agree to agree on this in writing. Verbal agreements are therefore not permissible and have not been hit. The law of the United Arab Emirates applies exclusively. The place of jurisdiction is Ras Al Khaimah / UAE.

7. Double Execution of Contract


The present document is available in duplicate. One is given to the member handed over, one of which is kept by the client.

8. Miscellaneous

The Member confirms that all information provided by him has been conscientious and truthful. In addition, he undertakes to inform the client of all contract-related changes in a timely manner.

9. Severability Clause

Should individual provisions of this contract be or become invalid in whole or in part, the validity of the remaining provisions shall remain unaffected.
